Completion of driver education instruction does not guarantee qualification for a driver license.

For a student to participate in Segment 2, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a level 1 license, which has been held for not less than 3 continuous months.

TERMS

1. The parent or guardian agrees to pay the amount of **\$50.00** which needs to be paid in full by **the first day of classroom instruction. (Credit Card, Cash, Check, and Money Order accepted)**
2. Requirements to pass the course: **80% on assignments; 70 % on the state test.**
3. The cost of materials and supplies for the class is \$0.00.
4. In case of a student's absence or emergency the school's policy is: **To take the course at a later date specified by the instructor.**
5. **There is no make-up policy. Students must retake the course if they miss a day.**

REFUND POLICY

1. If for any reason you decide to withdraw from the course before its completion, your refund will be based on the following:
 - a. *A full refund will be issued based on the following: (1) Student has paid in full, but classroom instruction has not yet begun. (2) Medical Emergency (Doctor's note required).*
 - b. A 50% refund (\$25) will be issued based on the following: ***Student missing a day, thus having to retake the course. No refund for students missing more than one day of class.***
